



OUR LADY OF GOOD COUNSEL RITE OF CHRISTIAN INITIATION OF ADULTS (RCIA)

Welcome to the Rite of Christian Initiation of Adults (RCIA). Congratulations on taking the first step in developing your faith! In this note, you will find a list of guidelines and requirements for your journey through Our Lady of Good Council Church's RCIA process. Please do not be overwhelmed by these requirements. Should you have any questions or concerns, we will be very happy to assist you.

The following list of requirements is for those of you who are considering whether you would like to receive Sacraments in the Catholic Church. If you have already received all of your Sacraments and are here to learn more about your faith, you do not have to fill in a registration form.

If you are here to learn more about the Catholic faith and are considering whether or not you would like to receive Sacraments, please fill out a registration form. Enrollment in the RCIA class is not a commitment to the Church. We will understand if you decide during any point of the RCIA process that you are not ready or willing to receive your Sacraments.

REQUIRED DOCUMENTS FOR THOSE RECEIVING SACRAMENTS

**Please begin to work to obtain the following applicable documents immediately.*

General information sheet (registration form): Is required.

Birth Certificate: A copy of your birth certificate is required only if you are to be fully initiated into the Roman Catholic Church. In other words, if you are going to be baptized or if you were baptized in another faith and will now be received into the Roman Catholic Church.

Baptismal Certificate: A copy of your Baptismal certificate is required if you are baptized in the Roman Catholic Church and will be receiving further Sacraments. If you were baptized in another faith, we do ask you for a copy of that Church's certificate or some other form of proof. If another form of proof is needed because your Baptismal certificate is impossible to obtain, please speak with an RCIA catechist.

1st Communion Certificate: If you have already received your first Holy Eucharist within the Roman Catholic Church, we require a copy of this certificate if it is not already noted on your Baptismal Certificate (usually located on the back of the certificate).

Marriage License: A copy of your marriage license is required if applicable.

MANDATORY ATTENDANCE

RCIA Classes: The RCIA process normally takes two years to complete. However, here at Our Lady of Good Counsel Church our program has been designed to be completed within a shorter period of time. It is therefore vital that you attend every scheduled class. Classes are normally conducted at 7:00 PM each Tuesday (subject to holidays and other changes). If you are not able to attend class due to illness or personal commitments, please call our office at 455-3012 and leave a message.

Sunday Masses: The RCIA participants attend the 8:30 AM Sunday Mass. A section at the front of the Church is reserved for the RCIA when in session. Attendance is required. Again, if you are not able to make it, please call our office at 455-3012 and leave a message.
